 - During the recent NAFSR Fire Committee one of the major discussion topics was the status of the Forest Service Heavy Airtanker Fleet (3000 gallon plus). At one time the national fleet had 44 aircraft. Currently the fleet is below 20 airworthy aircraft. While a couple of newer aircraft may be added, the fleet is woefully short of identified needs. Replacement aircraft such as the C-130's are probably more expensive than the FS can afford to purchase or maintain. The other topic of significant discussion was the continuing issue of fire policy and need for faster, more aggressive initial attack on unplanned ignitions. While the FS supports this concept, it is difficult to carry out with the decrease in firefighting resources.

NAFSR February 2012 Report

NAFSR Fire Committee Meeting 2/14/12

20 association members met with Jim Hubbard and Tom Harbour at the Forest Service Fire Training Center in Sacramento for a one day discussion of FS fires issues. Topping the agenda were budget outlook and continuing fire policy issue of allowing fires to burn without aggressive suppression efforts.

While the FS is not being hit by budget cuts as severely as some Department of Agriculture agencies, it is seeing a continuing erosion of base budgets, including fire preparedness and fuels management funding. The Department is looking at consolidation of support services similar to the infamous Albuquerque service center. And Secretary Salazar has mentioned the idea of Interior taking over federal fire management as a cost saving move. This suggestion has not been greeted with enthusiasm.

Based upon the discussions there are indications that the lack of wildfire knowledge, skills and experience is a major problem to the FS fire management program in the organization, the Administration and Congress. This lack of wildfire understanding will continue to plague the Forest Service for the foreseeable future, and contribute to the decline of fire fighting expertise, staffing and equipment. An example is air tankers: During the coming season there will fewer than 25 heavy air tankers nation wide, and the chances of the FS finding funds to increase the fleet with newer aircraft are slim to none.

The outlook for fire losses is grim as state fire agencies also experience an erosion of forces from budget cuts. Cal Fire, the largest state fire organization in the nation. is taking a 10-15% reduction.

Jim and Tom, in my opinion, are doing the best they can to stop program losses, but for the reasons I mentioned earlier, it is a hard and frustrating challenge.

National Park Shopping List

Wednesday I forwarded an information packet to you from NAFSR that was developed by Lyle Laverty, George Leonard and Hank Kasdan concerning the National Park Service's interest in expanding the park system with many of the new parks coming from national forest lands. I suggest it is important to share this information with members, and urge them to seriously consider the implications of the proposal and understand the importance of voicing their thoughts.

National Institute for the Prevention of Catastrophic Fire

This newly formed institute, in conjunction with College of the Siskiyous in Weed, CA and the Northern California Resource Center in Fort Jones, CA, is embarking on a national initiative to revitalize the national forests. It is working to build support for a Congressional Government Accountability Office review of the National Forest System and how well the system is meeting the intent of the Congressional passed Organic Act and subsequent laws directing management priorities. This initiative is the work of several NAFSR members and is encouraged by the Western Governor's Association staff, several congressional staffs and a growing number of rural western counties. When the package of papers supporting the initiative is completed they will be shared with our members.

Sustainable Northwest

Jim Golden and I will be representing NAFSR at the Sustainable Northwest's annual Rural Voices for Conservation and Communities Policy Conference in Vancouver, WA, March 7-9. Four western Regional Foresters will be taking part in the conference.

- 5. NAFSR Report: John Marker
 - John's full report is attached as Attachment B. Highlights:
 - This is a critical time, politically, for the Forest Service. The biggest issues include:
 - Fire Policy: 1/3 of heavy and medium helicopters will not be available because of budget reductions for the coming season. The FS initial attack ground forces also have been reduced to minimum or below levels in some parts of the West.
 - > Reforesting Burns
 - > Travel Management
 - The Forest Service needs political support for forest management.
 - NAFSR is trying to build coalitions to emphasize the importance of National Forests, and trying to figure out how to get more retirees involved in the process.

NAFSR Report to "Oldsmokeys" BOD April 2012 - Attachment B

This an unusually long report, but the national forests and Forest Service are facing critical times, and I think it is important that retirees, NAFSR members or not, are aware of some of the major problems the land and the "Outfit" face.

Before plunging into the latest FS issues I need to offer some prospective on the "Outfit "Recently I had coffee with a congressional staff member to discuss Forest Service and national forest issues. He mentioned at the beginning of the conversation most of the FS people are doing great work under trying conditions. Maybe 20% of the units in his area are involved in activities and/or issues requiring his Congressman's attention.

As retirees discuss issues, frustrations and concern it is important to remember the good work being done. NAFSR tries to do this with the John R. McGuire Award given to FS people who are doing outstanding work and represent by their performance the values retirees think important. I now have a sticky note on my monitor to remind me, that is spite of the constant flow of negative information, good work is being done and superb FS people are doing it.

However, in this era of 24 hour news cycles, political micro management, ideological debates, controversy is a growth industry. There are also many people, some inside, but most outside the FS, involved in natural resource decisions who do not have adequate training, experience or understanding of the importance of natural resources to the well being of citizens. The members of NAFSR, now almost at 1,000 strong, are committed to the national forests and Forest Service and helping to make things better.

Current Major Issues:

Fire Policy and Fire Management: Debate about fire suppression policy continues to be an unresolved problem. To most retirees the concept of aggressive initial attack with the objective of fast control of wildfires still makes sense unless there is a good reason and well thought out plan for an accidental fires to be allowed to burn. The fuzziness about wildfire policy makes it difficult to have an effective and efficient fire protection program, and is contributing to the increasing damage to both national forest and private land damage and property destruction

Budget cut backs are being felt throughout the service including fire. National resources such as aviation are greatly diminished. Heavy air tankers are now at a count of 13 or 14 nationally from 44 a decade ago. We have been told heavy lift helicopter and medium helicopter are being cut by up to one third. We have no reliable figures on initial attack smokejumpers, crews or engines, but see no reason to be optimistic. And the erosion of experienced fire leaders by retirement continues.

Travel Management and Law Enforcement: In 2005 national forests were directed to develop plans that would reduce the miles of Forest Service roads while still maintaining a transportation system that would serve resource protection, forest management and public use. Many forests have developed plans with little public controversy. However, in the West there are forests number of forests having difficulties getting public acceptance of plans Public involvement and work with local governments may be part of the issue, but in several cases the enforcement of travel plans by FS law enforcement is a factor.

The public and county Sheriffs in most of the problem areas object to what they see as agency law enforcement over stepping its authority and infringing on county Sheriff's constitutional authority and responsibilities as well as infringing on the rights of people to use their land. This is a complicated issue involving more than travel restriction and law enforcement, It has created some serious legal, political, social and FS management concerns. NAFSR people are informally working to understand the complications and issues to see if there is an appropriate problem solving role for retirees.

Something of Value: The National Forest System

Congressional Action is Needed for the Revitalization of the National Forest System.

March 12, 2012

EXECUTIVE SUMMARY

America's 193 million-acre National Forest System is in serious decline. The United States Forest Service (USFS) was created to be the congressional designated manager of the forests and to be the leader of professional forestry in the United States. As much through designed neglect as benign neglect, the national forests are being allowed to change from productive forests to fire-prone, insect-infested, and disease-wracked lands of declining value to the public, and the USFS that manages them for their citizen-owners is declining in its ability to carry out its mission of "caring for the land and serving people." Congress must act immediately to save the National Forest System and its invaluable commodity and amenity resources, and to restore and revitalize the beleaguered USFS charged with their management.

During the past decade, the natural resources on over 12 million acres (an area larger than the State of Maryland) of National Forest System lands have been damaged or destroyed by catastrophic wildfires, insects, and disease. This devastation is a consequence primarily of improper and inadequate management in a time of rapidly changing environmental conditions caused by climate change. Science-based resource management by Forest Service professionals has been preempted by those with ideological agendas and the political power to impose them. Congress's statutory direction for management of the national forests on a sustained yield-multiple use basis has been subverted by special interest groups. This situation will only get worse without immediate congressional intervention.

Congress must act now to charter a comprehensive review of the legislated mission and physical status of the forests and their resources, and then reverse and remedy the situations in those forests and their administration that threaten the nation's economical and ecological well-being. If it does not, and current trends continues, the nation's needs for vital economic goods and ecosystem services provided by the National Forest System will not be met (such as water), and Forest Service capabilities to manage the national forests will decline with the decline of its corps of professional resource managers and other specialists.

We believe the necessary review would best be led by a new public land law review commission, or Congress's investigative arm, the Government Accountability Office (GAO), with input by members of the Forest Service along with representatives of state and local governments directly concerned with national forest issues, citizen dependent on the forests, resource management experts, and user group members. This review should focus on: (1) the biological and physical condition of the National Forest System; (2) the management needs and challenges which must be met to restore those lands and resources through active management, as well as restore public confidence in the process; and (3) The indicators of needed service and products being delivered to American citizens. As a result of this review, Congress should: (1) revise the often-conflicting statutes governing National Forest System management and stewardship; and (2) revise, restore and reaffirm the mission of the Forest Service to manage those lands to produce "the greatest good for the greatest number in the long run" that was its original charge, as well as provide for accomplishment of that mission.

Report from Jim Golden, Chair of NAFSR

In late February I presented our paper on the Reforestation Issue to the annual meeting of the **Inland Empire Reforestation Council** (IERC) in Coeur d'Alene Idaho, at their invitation. Their event was well attended with approximately 200 people present. The make-up of the meeting attendees was 40% state agencies, 40% private industry, and 20% USFS. There were also quite a few students and faculty from Idaho and Montana.

Most of the day's presentations were technical papers on reforestation topics.

I used a PowerPoint slide show to aid my presentation of "Reforestation Needs in the National Forest System". I covered the goals, method, results, conclusions, commendations and recommendations from the report. I also discussed the response from the Chief's office as well as some continuing concerns.

For instance, when I discussed the situation cited in our report where large burned areas were made off-limits to FS employees by well-meaning line officers (for reasons of safety), preventing any on the ground assessment of reforestation needs for many years, I asked the room if anyone thought that was a rational policy. Not one hand went up!

Questions from the floor centered on capacity and policy. Some were concerned about nursery capacity should an increase in FS reforestation come about. There were concerns about the fire size and impacts to adjacent landowners. There were also quite a few questions about our organization and our top issues.

I also attended the annual policy meeting of **Rural Voices for Conservation Coalition** in Vancouver WA in March. Also in attendance from NAFSR was John Marker, our regional representative from the Pacific Northwest Region. We took an active role in the policy discussions that centered around forest restoration, budget, community collaboration Discussions also centered around the emerging topics of stewardship reauthorization, the Farm Bill, the Energy Bill, reauthorization of Payments to Counties, and other issues that are important to all of us.

Regional Foresters (and 1 Acting RF) from 5 regions attended and held a panel discussion on forest restoration and other pressing issues in the Forest Service.

I asked them what their most pressing issues were related to the budget outlook. All mentioned the coming fire season in some way. Harv Forsgren (R4) mentioned the likelihood of the resumption of fire transfer this coming year should we have a significant fire season. Kent Connaughton (R6) spoke to the difficulty of reducing the size of the workforce and the immediate impact on FS capacity to get work done. Randy Moore (R5) also added that budget reduction would strain some well-established partnerships that were succeeding in getting important work done. Beth Pendleton (R10) was most concerned about the viability of rural communities and how the presence of well-educated FS employees was such an asset to small towns. But also that FS programs are an important part of local economies generally. Gene DeGayner (Acting RF for R-) was concerned about fewer dollars getting to important timber projects that were critical to restoration efforts.

There were some outstanding presentations on the use of stewardship contracting as well on the current focus on landscape level restoration. Local collaborative members also presented some of their projects to the group for discussion.

RVCC has become one of the leading advocates for common sense community driven forest management in the West, and NAFSR and RVCC have joined together many times to endorse legislative proposals in Congress. This was an impressive gathering of people concerned about both rural communities and the condition of their forests!

On a different note, I noticed that there is about to be another survey of federal agencies regarding morale and the best places to work. It also has come to my attention that there have been widespread instances of disciplinary letters issued to Regional Foresters and Forest Supervisors for not getting all of their performance reviews filed by the due date! (Why no disciplinary letters for not improving the condition of our National Forests!) And, astonishingly, it was only mid-March when USDA finally allowed temporary hiring to proceed without the personal approval of Regional Foresters. Yes, even Forest Supervisors did not have the authority to hire (or re-hire) temporary employees! Wonder what kind of grade the FS will get on this latest morale survey. I hope the USDA Secretary's office is prepared to take a bow when the results appear.

It would be nice to write an update saying, "There is nothing to report." But old people dream too much.

PNWFSA's NAFSR Report for June 2012

The NAFSR organization is not directly involved in the following issues. However, many retirees who are NAFSR members are active in the issues as individuals. It is likely NAFSR will become involved in some of the issues as they develop and NAFSR resources are available.

Fire Policy:

Fires in Regions 2 and 3 during the last six weeks have brought both the USFS's ability to fight fire and its policy of continuing to allow some lighting fires to burn in Wilderness areas into public and political focus again. The High Park Fire in R-2 near Fort Collins, Waldo Fire in Colorado Springs, the Whitewater-Baldy Fire Northwest of Albuquerque, NM and Little Bear Fire on the edge of Ruidoso are the major attention getters. The four fires have burned close to 600,000 acres, killed one person, destroyed some 600 homes and other structures since mid May. The Little Bear Fire has attracted the most negative political attention so far.

Congressman Steven Pearce (R-NM) has confronted the Secretary of Agriculture and the Chief about fire policy issues and fire attack for major fires in New Mexico. At a press conference in Ruidoso the Chief and Secretary added to the controversy with some poorly chosen words about too much fire suppression and the need to introduce fire to the land. These remarks were made against the back drop of pictures of the fire burning into the edge of Ruidoso where 242 homes had burned. Protests in the community over "letting fires burn" and lack of aggressive firefighting have lead Congressman Pearce to have several meetings with the Chief and consider an investigation of Forest Service fire control efforts. The FS did not allow the Little Bear Fire to burn, and it did attack the fire when it was discovered, but the community perception was the fire was allowed to burn.. Drought conditions, high winds and possibly shortage of fire resources contributed to the fire escaping. The handling of the Whitewater-Baldy Fire was different. It did start in Wilderness by lightning and was monitored for several days before suppression began.

The High Park and Waldo fires were attack quickly after discovery, but wind and dry fuels created more fire than the fire forces could handle with available resources. So far there has been little concern expressed by the public or community leaders about the firefighting effort. One woman was trapped in her home and killed by the High Park fire. Resource and economic damage from the fires is heavy.

Serious fires are also burning in Utah, Montana, California, Nevada and Arizona. While we may still be wearing fleece and rain gear in the NW, the rest of the West is hot, dry.

We have heard from a R-4 retiree, Glann Bradley, that in R-4 a memo has come out telling forests not to mess with fires, put them out.

Travel Management:

The unhappiness over many of the national forests travel management plans is not attracting national media attention, but the issue is far from resolved. Several forests have backed off their plans and are doing reviews with more intense public involvement, which is helping calm some public concerns. But there are still forests where the issue remains raw and the controversy has not slackened. County sheriffs are major players in the debate because of their responsibilities for both law enforcement and public safety. This issue is not going to go away in the foreseeable future.

Air Tankers:

This issue is complex, confusing and far from resolution. Senator Wyden was the leader in surfacing the serious problem of shortage of heavy air tankers, and his lobbying the Senate plus the loss of two P2Vs in one day got media and Congressional attention. Upshot is the Forest Service will add 4 tankers in 2012 and 3 in 2013. However, depending upon the time it takes to get the aircraft through certification processes, it may be Fall of the year before more than two of the planes can join the fleet. In the meantime, the F5 is working to add on a loan basis several heavy airtankers coming from other agencies. It is also counting on the military C-130's for help, and adding several heavy lift helicopters from US contractors. There may be up to 16 heavy air tankers flying during all out fire fights along with the additional helicopters. A called when needed DC-10 will also be available. One issue not resolved is where is the money coming from and what happens in 2013 when budgets become even tighter.

Revitalizing the National Forests:

The Institute for the Elimination of Catastrophic Fires is sponsoring a national workshop to begin building a program aimed at convincing Congress it is time to take a hard look at the condition of the national forests, reaffirm the mission of the forests and take action to correct management problems which includes rebuilding the Forest Service. The workshop will be held July 17-18 at Mather Business Park in Sacramento, CA and is open to all interested people. See: www.stopwildfire.org. Retired FS leaders Jack Ward Thomas and Lyle Laverty will be among the workshop leaders.

In past weeks NAFSR members have been involved with a Revitalization of the National Forests Conference, testimony at a House hearing, reviewing Forest Service suppression actions in Region 3, and rebuttal to anti forest management propaganda in the media in Bonner's Ferry, Idaho and Missoula, Montana.

Revitalizing the National Forests:

Organized by the Institute for the Elimination of Catastrophic Fires, a branch of the Northern California Resource Center, a 501c 3 organization, located in Fort Jones, CA, the two day strategic planning meeting launched a national project to encourage Congress's active involved in determining the future of the national forests and the Forest Service. The meeting was held at the McClellan Business Park in Sacramento, CA and attended by over 50 people, primarily from western county governments and natural resource organizations, including NAFSR members. Jack Ward Thomas and Hal Salwasser opened the conference with their views of the national forest situation and challenges faced by the Forest Service. Frank Gladics, staff member of the Senate Energy and Natural Resource Committee added his perspective as did county commissioners from counties in California, Oregon and Arizona.

The participants used this overview in their deliberations of how to tackle the issue. The strategic plan will be released in draft form within the next few days and will focus on the importance of county governments dependent on national forest resources being leaders of the effort to revitalize forest management through direct action by Congress. Three critical issues included in the plan are fire control, national forest road management and the need for jobs.

NAFSR Testifies at House Hearing:

Hank Kashdan recently gave testimony supporting aggressive professional forest management at a House Resource Committee hearing chaired by Congressman Doc Hastings in DC. He was part of a group of conservation organizations, county government and state leaders invited to appear at the hearing.

Retiree to review FS fire suppression actions on major 2012 wildfires in New Mexico:

Bill Derr, former head of law enforcement in Region 5 has been asked by Congressman Steve Pearce (R-AZ) to review firefighting and fire management actions of the Forest Service for the Whitewater-Baldy and Little Bear fires that recently burned in New Mexico destroying almost 300 hundred homes and damaging several hundred thousand acres of public and private land. Derr, a member of NAFSR, was a fire prevention and suppression specialist in Southern California before moving into the law enforcement field. He is working with the FS to design his review.

Challenging the Nay-Sayers:

Barry Wynsma, recent retiree in Region 1 and NAFSR member has been writing op-eds for Evergreen on line magazine and papers in Bonner's Ferry, his home, and Missoula. The anti management crowd tried trashing his comments in the Missoula paper, and Barry decided not to be silent. His responses are factual and have generated other letters supporting his comments. August 2012 NAFSR Report to PNWFSA - Attachment B

The following topics dominate NAFSR time and energy currently: Fire Activity, Fire Budget Problems, Land Management Planning Rule and Travel Management Planning.

Fire Activity:

Currently some 500,000 acres in Region 4, 5, and 6 are on fire. Region 4 has two fires on the Salmon Challis over 100,000 acres in size, both partially in wilderness areas. One FS firefighter has been killed by a falling tree on a fire in Northern Idaho, several injuries reported and one fire truck in California destroyed. For more updated information including maps and photos go to InciWeb.org This year, as of this date, 43,104 fires have burned 7,106,319 acres compared to near 54,000 fires in 2011 burning 5,510, 332 acres.

Retiree Bill Derr, (R-5 Director of Law Enforcement) has completed his assignment with Congressman Steve Pearce to review suppression activity on major fires in Arizona this season. He is currently drafting his report. When it is released by Congressman Pearce I'll share it with you. Bill is a member of NAFSR, but was not representing the Association when working for the Congressman.

The heavy air tanker situation hasn't changed in spite of all the media attention to the proposal to move some military C-27J aircraft to the Forest Service. There are about 20 heavies available at this time through short term contracts and cooperative agreements with other fire agencies. The NAFSR Fire Committee chaired by Al West is working on an analysis of Forest Service aviation situation to develop recommendations for improving the aerial fire program.

Fire Budget:

During the recent Congressional budget process the reserve funds the agencies had accumulated for fire fighting expenses in bad years were taken away by the budget committee as part of the budget reduction process. Removal of these FLAME Act established funds has left the federal agencies, especially the Forest Service, in a world of budget hurt with core programs in danger of being cut back to pay the bills. NAFSR is working with many original FLAME sponsors to get help from Congress to pay the fire tab.

Land Management Planning Rule:

Recently a number of organizations and businesses depending upon national forests for resources or providing visitor services filed suit against the recently announced forest planning rule. NAFSR is also unhappy with the announced rule, but has not joined in the suit at this time. The intent is to give the Chief an opportunity to talk with members as the annual meeting about the rule, and also understand why major recommendations from the association were ignored. After the meeting NAFSR will make a decision about future actions on the planning rule.

Travel Management:

The unhappiness with the implementation of travel management plans on national forests is still festering. While some steps to resolve issues have been taken, so far the actions have not healed the wounds. Even forests where everything seemed to be resolved are starting to hear increased unhappiness from local people. NAFSR members are attempting to help resolve some of the travel issues in areas where they live, but it is a slow process. In many cases, members report, where once the Forest Service was seen as part of the community, it is now seen as a part from the community.

Grant Criteria, Attachment C:

The Pacific Northwest Forest Service Association (PNWFSA) will accept applications to help fund projects that further PNWFSA goals within the Pacific Northwest.

Applications are invited from private, non-profit, or non-governmental organizations pursing such goals.

Grant policy

Grants are awarded to organizations that satisfy the donation policy adopted by the PNWFSA Board of Directors on February 27, 2009. This policy specifies "Grants or gift proposals will be judged on the following criteria:

Does it further the OldSmokeys mission?

Will the project/program have a lasting influence on national forest management, natural resource management, and help sell the public on the importance of these resources?

Will it reach large numbers of people?

Can OldSmokey funds be leveraged with other funds?

Will a restoration or improvement project help sustain our Forest Service legacy? It is a project that 'feels good' to us and reminds us of our history and why we chose to throw in with the Outfit for our careers?"

NAFSR Report to Oldsmokey's September 2012 - Attachment B

NAFSR held its annual meeting at the 2012 Forest Service Reunion in Vail, CO. Here is a short summary of key issues on the meeting agenda;

The 2012 Fire Season in the West is the most intense since 2008, and may stay active into November in most of the West. Something close to a million acres has burned in Montana and Idaho so far. Washington, Oregon and California are also experiencing large fires. While it is not politically correct to mention the lack of firefighting resources, it is a major issue to people fighting the fires. Aviation resources are in short supply, and there is a shortage of local crews, which means it is often difficult to mount an aggressive attack in the early stages of a fire.

Adding to the challenges of the fire season has been a shortage of fire funds for the Forest Service. The Congress in the 2012 Budget Cycle removed the FLAME reserve account as part of the Congressional deficit reduction effort. The reserve account was established to help federal agencies through exceptional fire years. By early July the Forest Service knew it was going to run out of firefighting funds and would have to use funds from core programs to pay the fire costs. However, some 97 conservation groups led by the Nature Conservancy, National Association of State Foresters,, NAFSR, Society of American Foresters and American Forests mounted a successful campaign to get Congress to provide needed funds. In a last minute action before Congress adjourned for the election campaign, \$400 million was restored to the Forest Service fire fund. NAFSR was pleased to be able to play a leadership role in this effort thanks to its members making contacts with key federal legislators.

Disposition of national forest lands either through transfer to another federal agency or sale was of concern at the meeting. Several of our members who follow the political scene closely reported that both transfer of lands and sale are subjects of discussion in Congress by members of both parties. While it is hoped the possibility of either action will go away, there is the federal deficit issue and disposal of federal lands is a tempting "quick fix." Some members of Congress also are expressing the opinion the national forests are a liability.

On a more positive note, NAFSR is increasing its coalition building with an expanding network of other conservation organizations, and more contacts with members of Congress, state governments and counties in the West. During the reunion NAFSR also added to its membership with between 35 and 40 new members, bringing the total membership close to 600.

NAFSR October 2012 Report for Old Smokeys

The Reunion in Vail was rewarding for NAFSR in a number of ways, a significant increase in membership, and the opportunity for NAFSR members to have face to face meetings with Forest Service leadership to discuss a variety of issues. Thanks to the new members NAFSR is about to break the 600 membership mark, and discussions with Forest Service leaders helped us better understand some of the philosophical, political and management challenges the Forest Service is facing.

For NAFSR the coming months will involve a lot of hard discussions about how to approach current issues that are influencing national forest management and the operation of the Forest Service. NAFSR continues its commitment to the professional management of the forests to meet what it still considers the fundamental mission of these lands, the sustainable production of renewable natural resources. However, many members detect a change in focus within the agency as well in Congress and the Administration to a different and in our opinion poorly defined mission. We will be spending time trying to sort out if these perceptions of changing management direction are accurate.

Along with the learning curve about issues NAFSR intends to work hard to maintain relationships with the people of the Forest Service and actively support and recognize the good work that is being done in spite of budget, administrative, regulation and diminished workforce issues.

Many of us in NAFSR are concerned the growing fiscal crisis faced by the federal government combine with unhappiness in the rural West about public land protection and management may result in serious proposals to do away with large areas of federal land through sale or transfer to the states. Max Peterson mentioned the subject of land sales was a conversation topic of some legislators from both parties.

We agree with the comments about not going back to the old days, although there were many positive aspects of the past we believe are of value and not to be discarded out of hand.

The current issue generating significant public and political unrest in the West is a perception the Forest Service is not aggressively controlling wildfires. The NAFSR fire committee is attempting to sort fact from fiction and work with the Outfit to help it reduce this unrest before it results in negative political intervention.

The increased membership, especially "younger" retirees is important to helping NAFSR build solid support programs that will help build coalitions of conservation groups with shared beliefs about the national forests and their future. We need their currency to help us not depend too much on foggy memories for reference as we work through our "work list."

Looking to 2013, several major challenges will have NAFSR attention. Fire policy will be one of the major issues to be tackled. A NAFSR fire policy paper is in the final stages of drafting and will be presented to Leslie Weldon, Jim Hubbard and Tom Harbour at a Sacramento, CA NAFSR Fire Committee meeting in March of 2013. The major points in the paper can be characterized as a "Back to the future" with the paper strongly recommending a revitalization and motivation of the fire organization with emphasis on line officer fire training, more aggressive initial action on all wild fires, even in wilderness, during the peak burning periods of fire season.

A second major issue is public understanding of the mission of the national forests. This issue is becoming more critical as those wanting to stop management on the forests continue a strong campaign against any management that results in revenue to the public or changes the landscape. Most members of the public and political leadership see no reason to object. While there are significant money making projects on various forests, most are generally after long, complex and expensive public involvement and legal processes.

The federal budget crisis will certainly cause significant impact on the Forest Service's ability to manage and protect the forests. In public the FS leadership keeps a stiff upper lip, but in off the record conversations the fiscal outlook is grim. The financial situation is made even more difficult by various rules and directions coming from the department tightening the centralized control noose. NAFSR is sorting fact from fiction on this department micro management issue and will likely take a public position on the subject when the issue is clarified.

There is a brief case full of other issues NAFSR is working on, including building coalitions with other conservation groups and pushing for better training of forest officers. However, more about these issues at a later date.

Good news is word from Tom Thompson his health condition is improving. He has had a stem cell transplant and it appears to have been successful. He is still in the hospital, but is hoping to be released to complete recovery in the near future.
