## Historic Cispus River Bridge Collapses

During recent flooding on the Cowlitz Valley Ranger District, the Cispus River Bridge met its demise. The Cispus Valley Bridge was built in the summer of 1939 by Civilian Conservation Corps (CCC) enrollees from nearby Camp Lower Cispus. It spanned the Cispus River just north of the Tower Rock Campground. The bridge was determined eligible for the National Register of Historic Places because of its association with the CCC and because it was the longest single-span wooden Howe truss bridge remaining in the state of Washington. The bridge was closed to vehicle traffic in 1989. From 1940 to 1953, this bridge was the primary means of access to the Forest by Cispus Valley residents. (*Courtesy Roger Peterson, GPNF*)

## OldSmokeys Update

The number of visitors to our Web page continues to increase. At the time of this writing, the OldSmokeys page has been on the Internet for about 11 months and in that time it has received over 3200 visits. ## R6 Updates

1-17-02: Images of Ochoco's Hash Rock and Mill Creek Fires were among six photos honored in *Fire Management Today's* photo contest for 2001. The photos illustrated wildland fire, prescribed fire, wildland-urban interface, and other related topics. Region 6's audio/visual production specialist, **Tom Iraci**, took all six award-winning photos. In addition to the award, the photos will be featured in a future issue of *Fire Management Today*.

Three other photos submitted by Iraci did not receive awards, but the magazine's managing editor, Hutch Brown, writes of, "But all are fine photos and might be used to illustrate articles in forthcoming issues of *Fire Management Today*. We deeply appreciate receiving them."

1-31-02: **Cathy Thein**, computer assistant at Mt. Baker-Snoqualmie NF, Mt. Baker RD, has been honored with GEICO's Public Service Award for Traffic Safety and Accident Prevention for her contributions to Skagit County Chapter of Mothers Against Drunk Drivers (MADD).

Cathy organizes the 'mock crashes' MADD stages at county high schools, in cooperation with the Washington State Patrol, local fire departments, and other organizations, and takes vacation time from work to staff the MADD booth at the county fair each year.

### Carrying the Torch

Jan 25 **Jason Emhoff**, **Wenatchee NF**, carried the Olympic Torch in the Tri-cities. Jason is recovering from severe hand burns in the Thirty Mile Fire disaster.

The **Winema** and **Fremont NF** personnel-EEO/civil rights program manager **Gary Weldon** carried the Olympic Torch as it

passed through Klamath Falls on January 22. The community selected a total of eight runners from the Klamath Falls area. Gary's daughter, Jordan, was a support runner while the Torch traveled through Klamath Falls.

1-24-02: Reward money contributed for information leading to the arrest of the person or persons responsible for vandalizing a 267-foot sugar pine located in southeast Douglas County will soon be returned to donors.

Visitors to the landmark tree in **Tiller Ranger District, Umpqua National Forest**, reported the damage on December 3, 2000.

Once listed as the tallest sugar pine in the world, the tree was damaged when someone used a chainsaw to cut around the base of the tree in an attempt to "girdle" it.

According to **Chris Rusch**, botanist for Tiller Ranger District, the tree has survived the first year since the attack. It could take as long as four years to see if the tree will die. As soon as the damage was found, Rusch used grafting wax to seal the cut. Fire crews from District watered the tree throughout the summer.

2-21-02: **Cal Joyner**, Forest Supervisor/Center Manager of the San Juan Public Lands Center, has accepted the Director of Natural Resources position in the Pacific Northwest Region, effective April 21. Cal started his career on Waldport RD, Siuslaw NF, in 1980. Also, **Laurie Perrett**, former deputy Director of Fire and Aviation Management, who has been acting Director since **Mike Edrington** retired, has been selected as the permanent Director position.

## Federal Long Term Care Program

By the time you read this newsletter, the opportunity to enroll in the Federal Long Term Care Coverage program will have begun. The so-called "early enrollment" period began March 25. I will not try to explain anything about the program here, but just to alert anyone who has not kept informed on the program. There is much information on the internet. For example Fedweek gives updates at least twice a week, and of course offer booklets for a price. OPM website is also available. The Washington Post (D.C., that is) website keeps up on the subject. There are undoubtedly many other sources on the internet. If you do not have internet access, the NARFE magazine is very informative (*if you do not belong to NARFE, this may be good reason to join now*). The January and March issues have good info, and that will continue in future issues during the enrollment period. OPM just mailed a notice to every Federal employee and retiree (about 20 million people are eligible). It includes OPM website info and a return card for receiving hard copy notices in the future. You should have received this about February 26.

Right now (early March), there is not even any rate information available. That is still being worked out, but will be available by March 25. You need to get information regarding the "early enrollment" period, and the pros and cons of enrolling in this period vs. later. OPM advises that only those people who have already done their homework and know all about long-term care insurance should apply during the early enrollment period. Early enrollment will end May 15. A regular season will run from July 1 to the end of the year. Also look for information which deals with your own financial situation and how that might affect your decision on entering the program. If you get the feeling that it is all too complicated to deal with, ask for help from fellow retirees or other folks you rely on for such advice. I expect we will all be inundated with great offers from alternative vendors of this kind of service, so junk mail will fill your mail box. They have already found scammers issuing information using the "Partners" term to make you think it is the contracted firm.

All I can say at this time is that the program is not necessarily the right thing for each and every one of us, but it may be a very good alternative for many. Your golden rule should be to make an informed decision on the basis of good reason.

## MEMBERS CORNER

### Letters from Members

These first few comments are in respect of Jim Seabaugh (*see Obits*)

#### Denny Caird

I think the best thing we can do at times like these is simply to remember the good things about these men. Jim Seabaugh was without a doubt the best field photo-interpreter I ever met, and he forgot more about sale layout than most of us ever knew. When Virgil Binkley started up the Logging Specialists Program in R6, in 1972, Jim was the only one in the "Original Eight" that didn't have a degree in Forest Engineering. He basically taught himself all the mechanics stuff before the rest of us ever knew we needed to know it.

The last time I spoke with Jim Seabaugh, it concerned a couple of shirt-tail relatives of his---Rush (of talk radio) and David Limbaugh. I think Rush and David's grandfather was Jim's uncle. If you follow Rush at all, you know that the old man practiced law until he was 103, when he died. Before the uncle passed away, Jim and Penny made a trip to Cape Girardeau, MO, to visit Jim's family, and while there stopped by the law offices to see his uncle. Jim had just bought a new 4x4 pickup and offered to take the elder Limbaugh for a ride in it. According to Jim, he had to lift Penny into the truck as she was ill and it was a pretty tall truck, but "the old man just hopped up in there!" This whole episode began when I e-mailed David Limbaugh to ask him why so many people from Cape Girardeau have names ending in "baugh", as the only other person from there that I knew was named Seabaugh. He told me that Jim was a relative. I still don't know why they all end in "baugh", but it seems they sought each other out and got married.

#### Wendall Jones

My first introduction to Jim Seabaugh was when they created the Mill City RD, Willamette NF, in early 1959. Jim came there as a sale layout expert. I don't think the FS had invented the title Logging Engineer at that time. The Mill City

RD got most of the really tough ground from the original Detroit RD. In the early 50's, the FS did experimental logging with untested skyline logging equipment and procedures at Cascade Head Experimental Forest, on the Oregon Coast. This recently developed big-time skyline logging system (the Skycar) and Jim's expertise was what they needed. Jim laid out a number of skyline units that would take a full day just to walk from one end to the other, but Jim did it faster. This country was so tough that you couldn't go much faster downhill than uphill, without serious risks. Jim probably made the trip many times on each unit. Those were the days--Guys like Seabaugh, no NEPA, no news media hanging around, and we all worked hard and slept well.

### John H Brillhart, Sr.

John died on January 13, 2002, at age 90. He was a Lifetime member and Past President of the 30 Year Club. He was born on August 10, 1911, in Lancaster, PA. John graduated from Penn State in 1934 in Forest Management. He later received a Master's from Syracuse in 1949. He married Ruth Crider in 1935 (Ruth also died recently; her obituary was in the Winter newsletter).
