ARTICLE 5, Optional Provisions

- 1. "This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to such organizations that qualify as exempt organizations under Paragraph 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code."
- 2. "No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of this corporation."
- 3. "No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence liegislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

 Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Paragraph 501)c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code."
- 4. "Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Paragraph 501(c)(3) of the Internal Revenue Tax Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the court appropriate juristiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as that court shall determine, which are organized and operated exclusivelyfor such purposes."

IX. DISSOLUTION

In the event this Association is dissolved, all assets shall be transferred to another non-profit organization as designated by the executive board.
