### Incoming President's Message

The 30-Year Club Board needs some advise from you about several issues important to the Club's future. However, before starting a discussion I need to say thank you to many members who have served the Club well during the past year.

First, thanks to Dave Jay for his service as president during the past year, and his leadership to launch several initiatives improving Club management, meetings and recruiting. Dave Scott deserves a "well done" as he leaves the Board after almost a decade of outstanding service, including a term as president. Bob McQuown is stepping down as newsletter editor, and turning the word processor over to Wendall Jones. We owe Bob a big round of applause for producing an outstanding newsletter that is so important to 30-Year Club members.

Cherie and Fred Cooper deserve special thanks for organizing our successful Spring Banquet. If you missed it, you missed a superb event. We had great food, and a fine program of memories from the good old days in the outfit. Bev Pratt, Jack Smith, Jerry Allen and Wendall Jones shared stories, mostly true, of people and events that made Uncle Sam's Forest

Rangers special.

Finally, I want to thank the members of the Board who continue to serve for their interest and dedication to the 30-Year Club. We wouldn't exist without their efforts.

The Board would appreciate your comments on the following issues: Finance is one, another recruitment and retention of members and finally our relationship with current Forest Service management.

Currently operation costs, i.e., the newsletter, supporting the picnic and banquet, dues' collection, taxes, and routine business expenses, exceed our income from dues. We are using the income from our \$50,000 savings account to keep us in the black. Board members have spent a lot of time looking for ways to cut expenses, but we have reached the point where further reductions will affect Club programs.

The largest single expense is the newsletter. In spite of the wonders of computers the cost of production continues upward. Printing, paper and postage are the major expense items, and Bob has chased these expenses as hard as he can with only limited success. The bottom line is the newsletter is getting more expensive and our

income isn't keeping up with costs.

The cost of our two social events, the picnic and banquet, continue to climb. We try to keep each event self-supporting, however the Club has to be prepared to cover costs when attendance is below the break-even point. We're doing well with the picnic, but the banquet has been marginal in several of the past years. Incidentally, the Wildwood site used to be free to the Club, but now we pay a \$150 user fee.

Contributing to the tight financial situation is our dues' structure. Lifetime membership, a great bargain for members, creates a financial headache for budgeting. The one time payment is a problem in how to apportion the lump sum for current and future years' expenses. We haven't figured this issue out, and an accountant has told us there is no easy answer. One option for members to consider is doing away with the lifetime membership option for new recruits.

An option the Board is not considering is a general dues increase.

We are also discussing the

future of our savings account. Obviously the interest from \$50,000 is a big plus in helping with current operating costs, but what about the future? We have no established policy for managing or using savings in the future, and we think the Club needs one. Should we be looking at our savings as a source for current operating funds, as capital funds for programs to help the Club grow or for some other purpose that benefits members?

We are concerned about membership recruitment and retention. The lifeblood of any organization is members, and we aren't doing as well as we would like in attracting people currently retiring. Your thinking on this subject would be appreciated.

Finally, the Board would also like to hear your thoughts on improving our relationships with current Forest Service management. The major organizational, personnel and philosophical changes that have taken place in the last decade have changed some traditions and values that were important during our careers. However, in spite of these upheavals there are good people in the outfit doing their best to "Care for the land, and serve the public." We believe it is important to the forests, the outfit and the alumni to be supportive of their efforts.

I realize we're asking some pretty open ended questions, but we really would appreciate your thoughts to help us look not only at current activities but also the future of the 30-Year Club. You can phone us, write us or use E-mail to contact any member of the Board with your advice and counsel (See the list of Board members with contact information in this copy of the newsletter.) We would appreciate your comments by July 1, 2000.

Our annual picnic this summer will be held at the same location as it has been for the last several years. For newcomers, it is the Mountain View Shelter at the BLM's Wildwood Recreation Area. Wildwood is located approximately 40 miles east of Portland on US 26, on the way to Mt. Hood.

After turning off US 26, follow the signs to the group picnic area and you'll be there. The BLM is charging an entry fee of \$3.00 per vehicle. Envelopes for the fee are in 'Self-Serve' dispensing machines. Disabled persons will not be charged this fee. Those with Golden Age Passports also will not be charged—simply put your passport number on the envelope, deposit it and put the stub on your dash. Golden Age Passports are available at most government offices and are a good deal.

The menu this year will include: Roast Baron of Beef, BBQ Chicken, biscuits & cornbread, fresh fruit, baked beans, potato salad, cole slaw, chips and ice-cream sundae. There will also be coffee, beer, wine, iced tea, lemonade and soft drinks.

You get all of this, plus a chance to chat with old friends, for only \$15.50 per person!

The 30 Year Club bus tour to the 3rd National Forest Service reunion in Missoula, Montana, September 4th thru 8th, is just about ready to hit the road! The tour bus will depart on September 3rd, 10 a.m., from the Troutdale Air Tanker Base at the Troutdale airport, and return to that same point at about 8:30 p.m. on September 8th. The itinerary is:

Box lunches will be provided for 9/3, 4, and 8. A mix of turkey, beef, ham, and vegetarian sandwiches will be available, along with fruit juices and soda.

**Closing the Loop - the Three R's**

Now it's up to you! There are three "R's" that require your immediate attention:

1) "Ride" - Completing payment for the transportation expense, which must be pre-paid to the bus company. Those who are going on the trip have paid a "down payment" of \$50 per person. The total bus cost per person, including customary gratuity for the driver, driver's lodging, and lunches for all three travel days, is estimated to be \$165, leaving a remaining balance of \$115 per person.

**The final payment of \$115 per person is due by July 24th**, so that we can meet the terms of our contract with the bus company. Please mail your final payment to 30 Year Club, P.O. Box 5583, Portland, OR 97228-5583.

**There is still room on the bus if you would like to sign up, but your need to act fast. Send your name (s) , address, phone number, and the required total payment of \$165 per person to the above address as soon as possible.**

2) "Rooms" - You must make reservations for your stay at the Quality Inn in Clarkston for the night of September 3rd. The Quality Inn phone number is (509) 758-9500. A block of rooms has been held for us. You must also make room reservations at the Holiday-Parkside Hotel in Missoula. Their phone number is 1(800) 399-0408. You will need a reservation for the nights of September 4th thru the 7th. The Reunion organizers have reserved a block of rooms, but they are going fast! If you are unable to get a room at the Holiday Inn-Parkside, there are a number of other motels in the general area that can be accessed by foot or on the Missoula bus line, the "Mountain Lion".

3) "Registration" - You must register with the Reunion organizers. The basic fee is \$55 per person (\$45 for spouses) but there are some optional activities that require additional payment. Last week I had the opportunity to visit the John Inskeep Environmental Learning Center located at Clackamas Community College in connection with my role as an advisory board member to the Northwest Service Academy, and AmeriCorps program I was involved in establishing before I retired.

In the course of the tour of the facility it was mentioned that they were in need of volunteers. Based on what they said they were looking for, I immediately thought of the 30 Year Club members and their wealth of knowledge that might be brought to bear at the center. What follows is the text of a message I received from Christine Finlayson, the Education Coordinator at the center:

"Our Volunteer Naturalist program is just getting started, and will be taking shape over the next few months. What we are hoping to do is create a group of trained volunteers who can serve as hosts, interpreters, and educators on the site, especially during afternoons, early evenings, and weekends. When the weather's nice, we have many casual visitors to our site (adults, families, and kids by themselves) who do not come through specific programs or classes, but visit simply to enjoy the site.

"We would like to have greeters and naturalists on-site who can answer questions about trees, plants, wildlife, water and watersheds (pond, creek), site history, etc. as well as people who might offer the occasional talk, guided walk, or activity. Activities could be for children, adults, or a combination of the two (families).

"Over the next few weeks, a student here will be gathering survey information from visitors about the types of naturalist activities and topics they would like to learn more about, so we should know more soon.

"Karen Olsen, our PT Volunteer Coordinator (kareno@clackamas.cc.or.us) or (503) 657-6958 Extension 2963, will be coordinating this program as it gets started.

"Another opportunity that may interest Forest Service folks is that we






